The Flow of Funds

Flow of funds

- 1. A swift bank transfer from the Investors International Bank Account to the Investment Company's (IC) bank account (details on signature) for \$60,000 US Dollars.
- 2. Money arrives and will require 24 hours to be cleared funds. At which point the Investor receives notification of the deposit and can view the account balance if they wish.
- 3. The gold will be tested to the satisfaction of the IC. The Investors representatives can be present or video proof for the Investor can be sent to them after the testing is complete.
- 4. At this point the weight, and purity % for the Dore will be confirmed.
- 5. The cash payment for the agreed price of gold will be made by Investment Company for the escorted gold.
- 6. The gold will then be stored in a secure locked box in A tier 1 facility such as MySafe in Nairobi with 4 levels of security to protect the gold.
- 7. The documentation for exportation of the gold to an agreed destination will commence on the same day as the gold is purchased. This will facilitate a timely exit from Nairobi or a nominated international airport within Kenya.
- 8. The Gold will be transported as hand luggage and will be always with the delivery team.
- 9. Along with the Document Preparation and within 72 hours of the purchase, the IC will purchase 3 air tickets business class to the destination in Dubai. At least one representative from the IC who has a current Minerals Dealers License from Kenya in precious cargo transit will be on the Flight and the Seller. The remaining ticket to be issued to a BCI manager to fly as well. Flight details including costs etc. will be given to the investor for their records.
- 10. The team will provide an in-flight update to the investor to confirm the goods are safe and in transit.
- 11. Flight lands at the destination, the Transit Team, and the Seller clear customs. Safe keeping will be arranged if the refinery is not open at the time of arrival.
- 12. The gold will be taken to the refinery in Dubai to get a safe keeping receipt. Once the refinery is open, final transit will take place. The team wait for the final assay report.
- 13. The Team will meet the Investor to review the process of this, the first trial run. The Investor together with Investment Company, will propose any changes they wish to make before finally agreeing a long term larger investment into the Investment Company.
- 14, Investment Documents and Shareholder agreements to be signed prior to trading commencing.



A, The CEO of BCI is the only signatory of the account with the investment funds in it.






Investor Security
